PARTITION OF 25 ST We, the undersigned, acting as incorporators of a non-profit corporation pursuant to chapter 617, o Florida Statutes, adopt the following articles of incorporation:

ARTICLE I



AMENDMENTS TO ARTICLES OF INCORPORATION

has adopted the following amendments to the Articles of Incorporation which have been approved by all shareholders on July 22, 1996.

Amendment to Article III: Purposes

The amended Article shall read as follows

The purposes of this organization is organized exclusively for religious, educational, and charitable purposes, including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under section 501(c)(3) of the Internal Revenue Code, or corresponding section of any future federal tax code. The overall goal of this organization is to promote Buddhism for the welfare of all human beings. The specific purposes for which this organization is organized are:

- To promote world peace and brotherhood.
- 2. To practice Buddha's teachings in order to achieve a mind of clarity, purity, and tranquillity
- 3. To provide social, educational, and cultural services to the community
- 4. To participate in community volunteer services and charitable activities

Additions to Articles of Incorporation:

Article VIII, Financing and Management

No part of the net earnings of the organization shall inure to the benefit of, or be distributed to its members, trustees, officers, or other private persons, except that the organization shall be authorized and empowered to pay reasonable compensation for service rendered and to make payments and distributions in furtherance of the purposes set forth in the purpose clause hereof. No substantial part of the activities of the organization shall be the carrying on of propaganda, or otherwise attempting to influence legislation. and the organization shall not participate in, on intervene in (including the publishing or distribution of statements) any political campaign on behalf of any candidate for public office. Notwithstanding any other provision of this document, the organization shall not carry on any other activities not permitted to be carried on (a) by an organization exempt from federal income tax under section 501(c)(3) of the Internal Revenue Code, corresponding section of any future federal tax code, or (b) by an organization, contributions to which are deductible under section 170 (c)(2) of the Internal Revenue Code, or corresponding section of any future federal tax code. Upon the dissolution of the organization, assets shall be distributed for one or more exempt purposes within the meaning of section 501 (c)(3) of the Internal Revenue Code, or corresponding section of

any future federal tax code, or shall be distributed to the federal government, or to a state or local government, for a public purpose. Any such assets not disposed of shall be disposed of by the Court of Common Pleas of the county in which the principal office of the organizations then located, exclusively for such purposes to such organization or organizations, as said Court shall determine, which are organized and operated exclusively for such purposes
