ARTICLES OF INCORPORATION

OF

The undersigned subscriber to these Articles of Incorporation is a natural person competent to contract and hereby form a non-profit Corporation under Chapter 617 of the Fiorida Statutes.

ARTICLE 1 - NAME

The name of the Corporation is THE MEADOWS OF ARCADIA HOMEOWNERS ASSOCIATION, INC., (hereinafter, "Corporation).
