ARTICLE I - NAME OF CORPORATION

The name of the corporation is CENTRAL VIERA INTERFAITH DISTRICT ASSOCIATION, INC. (hereinafter referred to as the "Corporation").

ARTICLE II - DATE OF FILING

The Corporation's Articles of Incorporation were filed with the Department of State on September 14, 1994.
