

Pursuant to the provisions of Sections 617.1402 and 617.1403 of the Florida Statutes, the undersigned Florida corporation hereby adopts the following Articles of Dissolution:

**ARTICLE II - NAME OF CORPORATION**

The name of the corporation is Wickham-95 Commercial District Association, Inc. (the "Corporation").

**ARTICLE III - DATE DISSOLUTION AUTHORIZED**

The dissolution of the Corporation was authorized on August 15, 2003.

**ARTICLE IV - APPROVAL OF DISSOLUTION**
