**ARTICLES OF DISSOLUTION  
OF  
WICKHAM COMMONS COMMERCIAL DISTRICT ASSOCIATION, INC.**

Pursuant to the provisions of Section 617.1401 of the Florida Statutes, the undersigned Florida corporation hereby adopts the following Articles of Dissolution:

**ARTICLE I - NAME OF CORPORATION**

The name of the corporation is WICKHAM COMMONS COMMERCIAL DISTRICT ASSOCIATION, INC. (hereinafter referred to as the "Corporation").

**ARTICLE II - DATE OF FILING**

The Corporation's Articles of Incorporation were filed with the Department of State on September 14, 1994.

**ARTICLE III - COMMENCEMENT OF AFFAIRS**

The Corporation has not commenced to conduct its affairs.

**ARTICLE IV - DEBTS**

The Corporation has no debts that remain unpaid.

**ARTICLE V - APPROVAL OF DISSOLUTION**

The dissolution was approved by a majority of the directors of the Corporation by written consent dated January 30, 2007, pursuant to Section 617.0821 of the Florida Statutes.

The Corporation shall be dissolved effective upon the filing of these Articles of Dissolution.
