Pursuant to the provisions of section 617.1006, Florida Statutes, the undersigned corporation adopts the following articles of amendment to its articles of incorporation.

PIRST:

Amendments adopted:

ARTICLE III

The purposes for which the organization is organized are exclusively charitable and educational within the menning of section 501(c)(3) of the Internal Revenue Code of 1986 or the corresponding provision of any future United States Internal Revenue law.

In order to fulfill the purposes for which the organization is organized, it will obtain boats, yachts, exotic cars, recreational vehicles for LR.S. authorized tax exempt organizations and use the net profits to operate a school dedicated to teaching our youth about the ocean and how it affects our environment.

The National Donations Institute, Inc. shall admit students of any race, color, national or ethnic origin to all rights, privileges, programs, and activities generally accorded or made available to students at the school.
