## ARTICLES OF INCORPORATION

*The Undersigned acting as incorporator(s) of a corporation pursuant to chapter 617, Florida Statutes, adopt(s) the following Articles of Incorporation:*

### ARTICLE I

#### Name

The name of the corporation shall be:

### ARTICLE II

#### Principal Place of business and mailing address

### ARTICLE III

The specific purpose(s) for which the corporation is organized is(are):

A nonprofit organization to service the Muslim communities of Homestead, Naranja, Florida City and the Upper and Lower Keys.

To establish a place of prayer and Islamic School. To build Mosques, Schools. Recreational and cultural centers and other structures to serve the Muslim Community.

To practice the Religion of Islam in accordance with the Islamic Principles and the Sunnah of the Prophet Muhammad(S.A.W).

To teach Islamic Studies and other beneficial studies not contrary to the teaching of Islam.

Membership will be open to all Muslims as specified in the above geographical areas and membership to any one who wishes to become a Muslim and additionally from any other Muslim who wishes to become members of MASJID UL-ISLAM.

#### **ARTICLE IV**

##### **Manner of election of directors**

The manner in which the directors are elected or appointed is as follows:

- 1) Initially the founding members shall constitute the Directors and will have the following titles and will be appointed or elected:
  - President
  - Vice-President
  - Secretary
  - Treasurer
  - Assistant Secretary/Treasurer
  - 2 Members-at-Large
- 2) Within Three(3) years of Incorporation a Democratic General election must be held to elect a new Board of Governors. The Board of Governors will reflect at least the following titles:
  1. President
  2. Vice-President
  3. Secretary
  4. Treasurer
  5. Assistant Secretary/Treasurer
  6. 2 Members-at Large
- 3) The elected Board of Directors will be given the task of drafting a New Constitution which will be presented to the members to vote on.
