### ARTICLES OF INCORPORATION OF

### CENTER FOR NONPROFIT MANAGEMENT OF CENTRAL FLORIDATION CONTROL FLORIDATION OF STATE

The undersigned, acting as the incorporator of Center for Nonprofit Management of Central Florida, Inc. under Chapter 617, Florida Statutes, submits the following Articles of Incorporation.

#### ARTICLE ONE: NAME

The name of the corporation is Center for Nonprofit Management of Central Florida, Inc.

### ARTICLE TWO: DURATION AND COMMENCEMENT

The Corporation will exist perpetually, commencing with the filing of these Articles of Incorporation with the Florida Department of State.

#### ARTICLE THREE: PURPOSE

The Corporation is organized exclusively for such charitable, educational, literary, or scientific purposes, as will qualify it for exemption from federal income tax as an organization described by Section 501(c)(3) of the Internal Revenue Code of 1986, or corresponding section of any future United States Internal Revenue Law. Within the scope of the foregoing, the Corporation is specifically organized and empowered:

The purposes for which this corporation is organized are: To strengthen the capacity of people in the nonprofit sector to attract and manage resources to meet and solve community problems and to enhance nonprofit management and leadership skills and examine current nonprofit issues in

workshops or classroom settings.

To accept, hold, administer, invest and disburse for such purposes or for other scientific, educational, literary, charitable or religious purposes, such funds as may from time to time be given to it by any person, persons or corporations; and receive gifts and make financial and other types of contributions and assistance to scientific, educational, literary, charitable and religious organizations; and

To engage in such other activities as are necessary, appropriate, or convenient to the furtherance of the foregoing stated purposes and permitted under the laws of Florida and of the United States.

No part of the net earnings of the Corporation shall inure to the benefit of, or be distributable to its members, directors, officers, or other private persons, unless such member. director, officer or other private person is itself an organization qualifying for exemption from federal income tax as an organization described by Section 501(c)(3) of the Internal Revenue Code of 1986 or the corresponding section of any future United States Internal Revenue Law and except as reasonable compensation for services rendered or to make payments and distributions in furtherance of the purposes set forth in this Article Three. No substantial part of the activities of the Corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation (except to the extent permitted pursuant to an election made under Section 501(h) of the Internal Revenue Code of 1986), and the Corporation shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of, or in opposition to, any candidate for public office. Notwithstanding any other provision of these Articles, the Corporation shall not carry on any activities not permitted to be carried on (a) by a corporation exempt from federal income tax under Section 501(c)(3) of the Internal Revenue Code of 1986, or corresponding section of any future United States Internal Revenue Law, or (b) by a corporation, contributions to which are deductible under Section 170(c)(2) of the Internal

Revenue Code of 1986, or corresponding section of any future United States Internal Revenue

Law.

ARTICLE FOUR: MEMBERS

The qualifications for members of the Corporation and the manner of their admission shall

be as regulated by the bylaws.

ARTICLE FIVE: INITIAL REGISTERED OFFICE AND AGENT

The street address of the initial registered office of the corporation is 1900 North Mills

Avenue, Suite 3, Orlando, Florida 32803 and the Corporation's initial registered agent at that

address is Sherry M. Abbott.

**ARTICLE SIX: ADDRESS** 

The address of the Corporation's initial principal office is 1900 North Mills Avenue, Suite

3, Orlando, Florida 32803. The Corporation's initial mailing address is 1900 North Mills Avenue,

Suite 3, Orlando, Florida 32803.

ARTICLE SEVEN: DIRECTORS

The board of directors of the Corporation shall consist of not less than three nor more

than eleven members. The Corporation's bylaws shall specify the number of directors to serve

ARTICLE EIGHT: INCORPORATOR

The name and street address of the incorporator is Sherry M. Abbott, Center for Nonprofit Management of Central Florida, 1900 North Mills Avenue, Suite 3, Orlando, Florida 32803. The incorporator of the Corporation assigns to the Corporation her rights under Section 617.013, Florida Statutes, to constitute a corporation.

ARTICLE NINE: DISSOLUTION

In the event of the dissolution of the Corporation, the residual assets of the Corporation shall be distributed for one or more exempt purposes within the meaning of Section 501(c)(3) of the Internal Revenue Code of 1986, or corresponding section of any future United States Internal Revenue Law, or shall be distributed to the federal government, or to a state or local government, to be used exclusively for public purposes. Any such assets not so disposed of shall be disposed of by the Circuit Court for the County in which the principal office of the Corporation is then located, exclusively for such purposes or to such organization or organizations, as said Court shall determine, which are organized and operated exclusively for such purposes.

**ARTICLE TEN: AMENDMENTS** 

The Corporation reserves the right to amend, alter, change, or repeal any provision in these Articles of Incorporation in the manner prescribed by law.
