The undersigned, acting as incorporator(s) of a corporation pursuant to Chapter 617, Florida Statutes, adopt(s) the following articles of incorporation for such corporation.

ARTICLE II

The period of duration of this corporation is perpetual, unless dissolved according to law. Corporate existence shall commence upon March 7TH, 1996.

ARTICLE III

The purpose or purposes for which the corporation is organized are:

The purpose of this church shall be to preach and propagate among all people the Gospel of Jesus Christ as Savior and Lord; and to conduct a program of worship, education and fellowship for the spiritual development of the members and for the winning of souls to Jesus Christ in the Greater Orlando area and throughout the world.


This corporation is organized under a non-stock basis.

ARTICLE VIII


