



ARTICLES OF INCORPORATION
(amended 8/24/97)

ARTICLE I

The name of the corporation is:

LIGHTHOUSE COMMUNITY CHURCH of Seminole County *Inc.*

and the initial principal address is:

203 Herrell Road; Winter Springs, Fl. 32708

ARTICLE II

The period of duration of this corporation is perpetual, unless dissolved according to law.
Corporate existence shall commence upon March 7th, 1996.

ARTICLE III

The purpose or purposes for which the corporation is organized are:
The purpose of this church shall be to preach and propagate among all people the Gospel of Jesus Christ as Savior and Lord; and to conduct a program of worship, education, and fellowship for the spiritual development of the members, and for the winning of souls to Jesus Christ in the Greater Orlando area and throughout the world.

ARTICLE IV

The qualifications for members and the manner of their admission are:
The members of this church shall be those who have trusted upon Jesus Christ as their Savior and Lord, and have been baptized, and have been accepted by a majority of the members of the corporation, present and voting. Members of this corporation shall remain members until death, withdrawal, transfer of membership, or until dismissed for cause by a majority of the members of said corporation, present and voting.

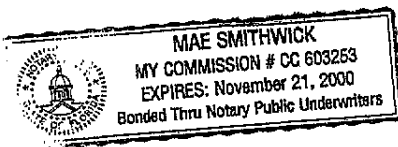

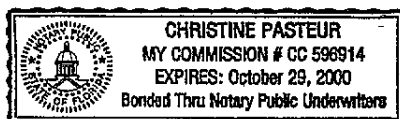

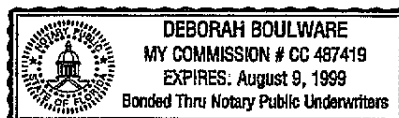
