





## BY-LAWS

To assume our share responsibility and the privilege of propagating the Gospel of Jesus Christ by all available means, both home and abroad, by the printed pages of Publicaciones Contacto magazine, radio broadcasting, missionary endeavors and otherwise, we do recognize ourselves as Christian in fellowship with and a part of the Body of Christ, and adopt the following by-laws and agree to be governed by them:






