*Pursuant to the provisions of section 617.1006, Florida Statutes, the undersigned Florida nonprofit corporation adopts the following articles of amendment to its articles of incorporation.*

**FIRST**, Amendments adopted:

**Article I was amended to read as follows:**

ARTICLE I

NAME

The name of the Corporation shall be TALLAHASSEE AREA CREW, INC.

**Articles II through III were not amended.**

**Article IV was amended to read as follows:**

ARTICLE IV

NONPROFIT PURPOSE

The purpose for which the Corporation is formed is educational and charitable, within the meaning of section 501(c)(3) of the Internal Revenue Code of 1986. In this connection, the Corporation's primary purpose is to provide educational, recreational, and social benefits to minors by operating, supporting, and promoting a youth crew (team rowing) program for minors in Tallahassee, Leon County, Florida, which contributes to the development of good character, good sportsmanship, and the educational development of such minors, and engaging in fund-raising to finance such program. In furtherance of this purpose, the Corporation shall have all general powers enumerated in chapter 617, Florida Statutes.

**Article V was not amended.**

**Article VII was deleted.**

**Article VIII was renumbered as Article VII and amended to read as follows:**

**ARTICLE VII**

**PRINCIPAL OFFICE**

The address of the principal office is located at 3540 Thomasville Road, Tallahassee, Florida 32308. The principal mailing address is Post Office Box 13941, Tallahassee, Florida 32317-3941.

**Article IX was renumbered as Article VIII and amended to read as follows:**

**ARTICLE VIII**

**ADDRESS FOR NOTICE**

The address to which the Secretary of State shall mail a copy of any notice required by law is Martha Harrell Chumbler, 4023 Roscrea Drive, Tallahassee, Florida 32308.

**Article X was renumbered as Article IX and amended to read as follows:**

**ARTICLE IX**

**REGISTERED AGENT**

The Corporation designates Martha Harrell Chumbler, whose address is 4023 Roscrea Drive, Tallahassee, Florida 32308, as its registered agent.

**Article XI was renumbered as Article X, but otherwise not amended.**

**Article XII was deleted.**

**Articles XIII is renumbered as Article XI, but not otherwise amended.**

**Article XIV was renumbered as Article XII and amended to read as follows:**

**ARTICLE XII**

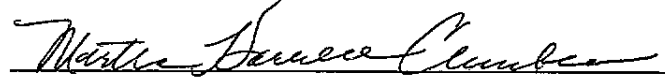
**ELECTION OF OFFICERS AND DIRECTORS**

**Articles XV was renumbered as Article XIII but was not otherwise amended.**

**SECOND:** The date of adoption of the amendments was May 19, 2001.

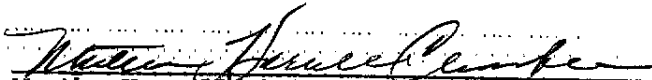
**THIRD:** The amendments were adopted by the members and the number of votes cast for the amendment was sufficient for approval.
