ARTICLES OF INCORPORATION OF ASOCIACION DE EX-CADETES DEL COLEGIO MILITAR LEONCIO FLORIDA INC.

ARTICLE I NAME

The name of this corporation is ASCCIACION DE EX-CADETES DEL COLEGIO MILITAR LEONCIO PRADO, FLORIDA INC. The English translation of this name is "Association of past students of Military School Leoncio Prado", /NC.

ARTICLE II DURATION

This corporation shall have perpetual existance commencing on the date of the filing of these Articles with the Department of State.

ARTICLE III PURPOSE

The purpose for which this corporation is organized is all non-profit purposes permitted under 26 U.S.C. §501(c)(3). Specifically, this corporation will provide professional and economical assistance to its members and their families.

ARTICLE IV CAPITAL STOCK

This corporation shall issue no stock.

ARTICLE V LOCATION

The Street, Address, City, County and State in which the principal offices of the corporation are to be located are, 3014 N.W. 79th Avenue, Miami, Dade County, Florida 33122. The Board of Directors may from time to time designate such other address and place for the principal office of this corporation as it may see fit.

ARTICLE VI INITIAL BOARD OF DIRECTORS

The manner in which directors are elected or appointed are contained in the By-Laws of this Corporation. This corporation shall have four (4) Directors initially. The number of Directors may be increased or diminished from time to time in accordance with By-Laws adopted by the members. ARTICLE VIII AMENDMENT

These Articles of Incorporation may be amended in the manner provided by law. Every amendment shall be approved by the Board of Directors, and approved by the majority of the members at a General Assembly meeting, unless all the Directors sign a written statement manifesting their intention that a certain amendment to these Articles of Incorporation be made.

ARTICLE IX LIMITATIONS

- 1. No part of the not earnings of this corporation shall inure to the benefit of or be distributable to its members, directors, officers or other private person except that this corporation shall be authorized and enpowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in this article.
- 2. No substantial part of the activities of this corporation shall be the carrying on of propaganda, or otherwise attempting, to influence legislation. This corporation shall not participate or intervene in any political campaign on behalf of any candidate for public office, including the publishing or distribution of statements.
- 3. No withstanding any other activities not permitted to be carried on by a corporation exempt from federal income tax under \$501(c)(3) of the Internal Revenue Code of 1954 or the corresponding provision of any future United States Internal Revenue Law, or by a corporation, contributions to which are deductible under \$170(c)(2) of the Internal Revenue Code of 1954 or the corresponding provision of any future United States Internal Revenue law.

ARTICLE X DISSOLUTION

On the dissolution of this corporation, the board of directors shall dispose of all of the assets of this corporation exclusively for the purposes of this corporation in the manner of the organizations that are organized and operated exclusively for charitable, educational, religious or scientific purposes and that shall at the time qualify as exempt organizations under \$501(c)(3) of the Internal Revenue Code of 1954 or the corresponding provision of any future United States Internal Revenue law, after paying or making provisions for the payment of all liabilities of this corporation. Any assets not so disposed of shall be disposed of by a court of competent jurisdiction in the county where the principal office of this corporation is then located exclusively for the purpose or to the organizations that the court determines are organized and operate exclusively for charitable, educational, religious or scientific purposes.

The qualifications for and manner of admission of members shall to regulated by the bylaws.

ARTICLE XII INITIAL REGISTERED OFFICE AND AGENT

The Street address of the initial registered office of this corporation is 3014 N.W. 79th Avenue, Miami, FL. 33122 and the name of the initial registered agent of this corporation at that address is Jose H. Barbaran.

ARTICLE XIII BYLAWS

The bylaws of the corporation shall be adopted by the board of directors.
