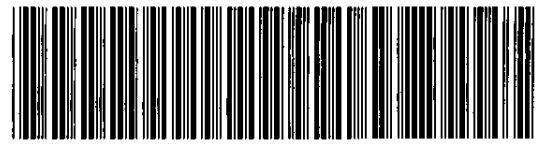


ARTICLE I
