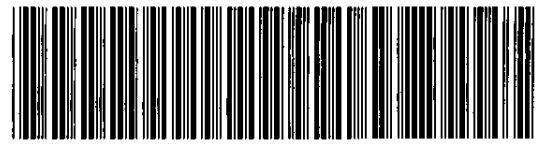


ARTICLE I
