

The manner in which the directors are elected or appointed is as follows:

A board of directors, consisting of a President, Vice-President, Treasurer, and Secretary, shall be elected yearly. These shall be nominated by the members of the organization, and elections shall be held at a General Assembly of the association held on the third Wednesday of December. The nominee with the majority vote will be the new elected board member. A minimum of 35% of members is needed for quorum.

#### ARTICLE V

The foregoing paragraph shall be construed as enumerating the purposes, objects, and powers of this corporation and no recitation, expression or declaration of specific powers or purposes herein enumerated shall be deemed to be exclusive, but it is hereby expressed and declared that all other lawful powers not inconsistent herewith are hereby included.

Upon dissolution of the corporation, assets shall be distributed for one or more exempt purposes within the meaning of section 501(c)(3) of the Internal Revenue Code, or corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government, for a public purpose. Any such assets not so disposed of shall be disposed of by the Court of Common Pleas of Hillsborough County, exclusively for such purposes or to such organization or organizations as said court shall determine, which are organized and operated exclusively for such purposes.


