Amendments to the Fishermen's Bounty Board of Directors of Pine Island, Inc.

Article I Make the following change:

The name of the corporation shall be: Fishermen's Bounty, Inc.

Article III Add the following:

The purposes for which the corporation is organized are exclusively religious, charitable, scientific, literary and educational within the meaning of section 501(c)(3) of the Internal Revenue Code of 1986 or the corresponding provision of any future United States Internal Revenue Law.

Article V Add the following:

Notwithstanding any other provision of these articles, this organization shall not carry on any activities not permitted to the carried on by any organization exempt from Federal income tax under section 501(c)(3) of the Internal Revenue Code of 1986 or the corresponding provision of any future United States Internal Revenue Law.

Article XI Add the following:

Upon the dissolution of the corporation, assets shall be distributed for one or more exempt purposes within the meaning of section 501(c)(3) of the Internal Revenue Code of 1986, or corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government, for a public purpose. Any such assets not so disposed of shall be disposed of by the court of Common Pleas of the county in which the purposes or to such organization or organizations, as said Court shall determine, which are organized and operated exclusively for such purposes.
