Name: The name of this nonprofit corporation shall be IN GOD WE TRUST, PARTY (for Purified Leadership) INC.

ARTICLE II

Duration: The duration of this nonprofit corporation shall be perpetual and its existence shall commence on April 29, 1996 at 12:00 Noon the Department of State for the State of Florida in Tallahassee, Florida.

ARTICLE III

Purpose: This nonprofit corporation is organized for educational, scientific, social, cultural, and charitable purposes for which a corporation not for profit may be incorporated under the laws of the United States of America and the State of Florida.

ARTICLE IV

Stock: This nonprofit corporation is organized upon a nonstock basis and shall not issue shares of stock.
