undersigned, acting as incorporators of a non-profit The corporation under the Not For Profit Corporation Act, adopt the following Articles of Incorporation for such corporation:

Article I. NAME:

The name of the corporation shall be:

Article II. TERM OF EXISTENCE:

The period of duration of the corporation is perpetual.

Article III. PRINCIPLE PLACE OF BUSINESS AND THE MAILING ADDRESS:

This corporation is organized for the following purposes:

- 1. To assist in comforting AIDS patients in hospitals, rest homes, and hospice centers that are dying after family and friends have abandoned them to die alone.

To take charge of, hold and manage all property, real and personal, that may at any time or in any manner come to vest in this corporation for any purposes whatsoever, whether by purchase, gift, grant, devise or otherwise, and to mortgage, sell or otherwise dispose of such property as the necessities of the corporation may require.
- 3. To engage in any other activities which are lawful in the State of Florida or the United States of America for non-profit corporations.

Article V. MEMBERSHIP:

Article VI. DIRECTORS:

The number of directors constituting the initial board of directors of the local community shall be no less than three. The persons who are to serve as initial directors are as follows:

No part of the net earnings of the corporation shall inure to the benefit of, or be distributable to, its members, trustees, officers or other private persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in Article Three hereof. No substantial part of the activities of the corporation shall be the carrying on of propaganda, or otherwise attempting, to influence legislation, and the corporation shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of any candidate for public office.

Notwithstanding any other provision of these articles, the corporation shall not carry on any other activities not permitted to be carried on by a corporation exempt from federal income tax under Section 501(c)(3) of the Internal Revenue Code of 1954 (or the corresponding provision of any future United States Internal Revenue Law).

Article X. AMENDMENT OF ARTICLES OF INCORPORATION:

The members shall have the power to adopt, amend, alter, change, or repeal the Articles of Incorporation when proposed and approved at a called membership meeting, with not less than a two-thirds vote of the members present at such meeting, as prescribed by the by-laws.

ARTICLE XI. STOCK:

The corporation is organized and shall be operated on a non-stock basis within the meaning of the Florida Not For Profit Corporation Act and shall not have the power to issue shares of any type or class of stock but may issue membership certificates if so provided in the by-laws.

Article XII. DISSOLUTION OF THE CORPORATION:

Upon dissolution of the corporation, the assets of the corporation remaining after payment of all debts and liabilities of the corporation shall be distributed for one or more exempt purposes within the meaning of Section 501(c)(3) of the Internal Revenue Code or the corresponding section of any future federal tax code.
