I, the undersigned incorporator, hereby make, acknowledge and file these Articles for Incorporation for the purpose of forming a corporation not-for-profit under the laws of the State of Florida.

ARTICLE I

Name: the name of this corporation is:

AIKIDO, Todai Dojo, Inc.

ARTICLE II

Registered office. The street address and city of the initial registered office and principal office of this Corporation is:

75 Hook Square
Miami Springs, FL 33166

and the name of the initial registered agent at such address is:

Ronald W. Herndon

The principal address and the registered office addresses are the same.

ARTICLE III

Term. The term of this Corporation shall commence with the filings of these Articles of a Incorporation. This Corporation shall exist perpetually, unless dissolved according to law.

ARTICLE IV

Non-stock Corporation. This Corporation is organized on a non-stock basis.

ARTICLE V

Qualification as Non-Profit Corporation. No part of the income of the Corporation shall be distributable to its members except in accordance with Section 617.0505 of the Florida Statutes.

ARTICLE VI

Purpose. The purpose for which this Corporation is organized is to carry on instruction, on a not for profit basis, of the martial art of AIKIDO (and any other martial art).

ARTICLE VII

Board of Directors. The number of the persons constituting the initial Board of Directors of the Corporation is eight, and the name and addresses of the persons who are to serve as the initial directors are:

The initial Board of Trustees shall serve until the first election of Directors. The manner of election of Directors shall be set forth in the bylaws.

ARTICLE VIII

Distribution of Assets on Dissolution. In the event of dissolution, the residual assets of the Corporation will be distributed in a manner consistent with the requirements of Chapter 617

of the Florida Statutes.

ARTICLE IX

Incorporator. The name and address of the incorporator is Ronald W. Herndon, 75 Hook Square, Miami Springs, FL 33166.

ARTICLE X

Bylaws. The bylaws of the Corporation shall be adopted by the Board of Directors.

ARTICLE XI

Amendments. Any amendments to these articles must be proposed by a member of the Board of Directors. Amendments shall be adopted by an affirmative vote of a majority of the Board of Directors present and voting at a meeting at which a quorum is present.
