ARTICLES OF INCORPORATION OF

PARALYZED VETERANS ASSOCIATION OF FLORIDA FOUNDATION, INC.

The undersigned by these Articles associate themselves for the purpose of forming a corporation not for profit under the Nonprofit Corporation Law of Florida, do hereby certify:

ARTICLE I.

The name of the Corporation shall be:

Paralyzed Voterans Association of Florida Foundation, Inc.

ARTICLE II.
ADDRESS OF PRINCIPAL OFFICE AND MAILING ADDRESS

The address of this principal office and mailing address of this corporation is:

ARTICLE III.

The duration of this Corporation shall be perpetual.

ARTICLE IV. PURPOSE

The purposes for which this organization is formed are confined to those which are strictly charitable, scientific and educational within the meaning of Section 501 (c) (3) of the Internal Revenue Code or corresponding sections for any future federal tax code, including:

(a) To receive and maintain a fund or funds of real or personal property, or both, and, subject to the restrictions and limitations hereinafter set forth, to use and apply the whole or any part of the income therefrom and the principal thereof exclusively for charitable, scientific, or educational purposes either directly or buy contributions to organizations, including Paralyzed Veterans Association of Florida, Inc.(PVAF), that qualify as exempt organizations under Section 501 (c) (3) of the Internal Revenue Code or corresponding section of any future federal tax code.



- (b) Without limiting the generality of the foregoing, the purposes for which this corporation shall include by way of illustration and not limitation: (i) to foster the exchange of information and education to the general public on the needs and problems of people who have a spinal cord dysfunction and people with catastrophic disabilities; (ii) to foster the educational opportunities of people with a spinal cord dysfunction through the making of grants to educational institutions for the establishment of student grant and loan funds, and through the making of direct grants or loans to people with a spinal cord dysfunction, with an interest, to enable them to meet the expenses of higher education and/or vocational goals; (iii) to foster medical research, for the cure, rehabilitation, or therapy of people with a spinal cord dysfunction; (iv) to provide people with spinal cord dysfunction and people with a catastrophic disability facilities and other services especially designed to meet their physical, social, and physiological needs such as assisted living, transportation, personal care attendant; (v) to make distributions to organizations, including Paralyzed Veterans Association of Florida, Inc., that qualify as exempt organizations under section 501 (c) (3) of the internal Revenue Code for any of the above purposes.
- (c) To do everything necessary, proper, advisable and convenient for the accomplishment of the purposes herein set forth, and to do all other things incidental to or connected with the purposes herein set forth, which are not forbidden by the Florida Nonprofit Corporation Act or by the Articles of Incorporation.

ARTICLE V. LIMITATIONS AND RESTRICTIONS

- A. No part of the not earnings of the Corporation shall inure to the benefit of any member, Director, officer of the Corporation, or any private individual (except that reasonable compensation may be paid for services rendered to or for the Corporation affecting one or more of its purposes), and no member, Director, officer of the Corporation, or any private individual shall be entitled to share in the distribution of any of the corporate assets on dissolution of the Corporation. No substantial part of the activities of the Corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the Corporation shall not participate in or intervene in (including the publication or distribution of statements) any political campaign on behalf of any candidate for public office.
- B. Notwithstanding any other provision of these Articles, the Corporation shall not conduct or carry on any activities not permitted to be conducted or carried on by an organization exempt from federal income tax under Section 501 (c) (3) of the Internal Revenue Code and its Regulations as they now exist or as they may hereafter be amended, or by an organization, contributions to which are deductible under Section 170 (c) (2) of such Code and Regulations as they now exist or as they may hereafter be amended.
- C. Upon the dissolution of the Corporation or the winding up of its affairs, the assets of the Corporation remaining after payment of all costs and expenses of such dissolution shall be distributed to Paralyzed Veterans Association of Florida, Inc. for use by charitable, scientific and educational organizations, including Paralyzed Veterans Association of Florida, which would then qualify under the provisions of Section 501 (c) (3) of the Internal Revenue Code and its Regulations as they now exist or as they may hereafter be amended and none of the assets will be distributed to any member, officer or director of the Corporation or to any private individual.

ARTICLE VI. MEMBERS

The members of the Corporation shall constitute all persons hereinafter named as subscribers and directors and such other persons as, from time to time hereafter, may become members, in the manner provided in the Bylaws of the Corporation or as may be elected by the members at each annual meeting.

ARTICLE VIII.
DIRECTORS

Directors may be removed and vacancies on the Board of Directors shall be filled in the manner provided in the Bylaws.
