ARTICLES OF INCORPORATION

OF

SOUTH FLORIDA YOUTH ATHLETIC ASSOCIATION, INC.

We, the undersigned residents of the State of Florida, buing twenty-one (21) years or more of age, do hereby associate ourselves together for the purpose of forming a nonprofit corporation under the statutes of the State of Florida.

ARTICLE I

The name of the Corporation is SOUTH FLORIDA YOUTH ATHLETIC ASSOCIATION, INC. and the location shall be 307 N.W. 3rd Court, Hallandale, Florida 33009, County of Broward, State of Florida and the name of the initial registered agent at such address is Julius Brown.

ARTICLE II

The period of duration of this nonprofit corporation shall be perpetual.

ARTICLE III

The purpose of this corporation shall be to promote and encourage the sport, pleasure, exercise, and recreation of its members; to promote sociability and friendship among its members; and to manage and conduct entertainments, excursions, and social meetings of its members.

ARTICLE_IV

The corporation shall be nonstock, and no dividends or pecuniary profits shall be declared or paid to the members thereof.

No part of the net earnings of the corporation shall inure to the benefit of or be distributed to its members, directors, officers, or other private personas, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered to or for the corporation in carrying out one or more of its purposes.

ARTICLE V

The number of directors constituting the initial board of the corporation is three (3), and the names and addresses of the persons who are to serve as initial directors are as follows:

- (1) Julius Brown 307 N.W. 3rd Court Hallandale, FL 33009
- (2) David Daniels 732 S.W. 7th Terrace Hallandale, FL 33009
- (3) Israel Hepburn 2440 West Pinetree Drive Miramar, FL 33023

ARTICLE VI

The manner of which the officers are to be elected by the members is as follows:

Annual elections of President who will appoint two (2) Vice Presidents with members electing treasurer and secretary to run 2 concurrent terms. President may be re-elected for subsequent terms.

ARTICLE VII

The general officers of the corporation shall be president, vice-president, secretary, and treasurer.

The principal duties of the president shall be to preside at all meetings of the members and the board of directors and to have general supervision of the affairs of the corporation.

The principal duties of the vice-president(s) shall be to discharge the duties of the president in the event of absence or disability, for any cause whatsoever, of the president.

The principal duties of the secretary shall be to countersign all deeds, leases, and conveyances executed by the corporation, affix the seal of the corporation thereto and to such other papers as shall be required or directed to be sealed, and to keep a record of the proceedings of the board of directors, and to safely and systematically keep all books, papers, records, and documents belonging to the corporation, or in any way pertaining to the business thereof, except the books and records incidental to the duties of the duties of the treasurer.

The principal duties of the treasurer shall be to keep an account of all monies, credits, and property of any and every nature of the corporation which shall come into his/her hands, and to keep an accurate account of all monies received and disbursed and of proper vouchers for monies disbursed, and to render such accounts, statements, and inventories of monies received and disbursed and of money and property on hand, and generally of all matters pertaining to his/her office, as shall be required by the board of directors.

The board of directors may provide for the appointment of such additional officers as they may deem for the best interest of the corporation.

Whenever the board of directors may so order, any two offices, the duties of which do not conflict, may be held by one person.

The officers shall perform such additional or different duties as shall from time to time be imposed or required by the board of directors, or as may be prescribed from time to time by the bylaws.

The officers shall be approved by the directors, who shall first be elected by the members of the corporation.

ARTICLE IX

The conditions and regulations of membership and the rights and other privileges of the classes of membership shall be determined and fixed by the bylaws.

ARTICLE X

These articles may be amended in the manner provided by statute at the time of amendment.
