ARTICLES OF INCORPORATION

IGLESIA MISIONERA EL BUEN PASTOR, A.D., INCIALLAMASSEE, FLORIDA

(Missionary Church The Good Sheppard, A.G., Inc.)

#### Not For Profit

We, the undersigned person(s) of the State of Florida, all of whom are of legal age, each being competent to contract, hereby from ourselves and our successor into a corporation Not For Profit under the laws of the State of Florida, and hereby adopt the following Articles of Incorporation.

### ARTICLE I

The name of this Corporation shall be Iglesia Misionera El Buen Pastor, A.D., Inc. (Missionary Church The Good Sheppard, A.G., Inc.) with location of its principal business shall be 3000 S.W. 107th Avenue, Miami, Florida 33165, but, it may relocate and establish other places either within or without the State of Florida as the Board of Directors may from time to time determine.

#### ARTICLE II Purpose

The objects, purpose and powers of this Corporation and the General nature of the business it proposes to transact are:
