Pursuant to the provisions of Florida Non-Profit Corporation Act, the undersigned corporation adopts the following Article of Amendment to its Articles of Incorporation which: The corporation has no members. The following amendments to the Articles of incorporation was adopted by the corporation board of directors on May 15, 1997, at 2855 Apalachoo Parkway, Apt. E-214, Tallahasaco, Florida 32301

The Articles of Incorporation, Articles 7 and 8 are hereby amended so as to read as follows:

SEVEN: No part of the net carnings of the corporation shall inure to the benefit of, or be distributable to its members, trustees, directors, officers or other private persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of Section 501(c)(3) purposes.
