1. The name of this corporation shall be PowerPak Ministries, Inc., and its principal location shall be 1506 Kirby Street, the city of Palatka, state of Florida, but branches thereof may be established at any place in or out of the state of Florida, (organized under Section 501 (c) 3 of the Internal Revenue Code).
2. The general nature of the object of this corporation shall be to interpret and expound the Holy Bible and to maintain it as the foundation of all spiritual truth; to establish churches (if deemed necessary); to celebrate marriages; and, to conduct burials.
