

### ARTICLES OF INCORPORATION OF

YOUNG ADULTS CONSCIOUS INDEPENDENT DEVELOPMENT, INC.
A FLORIDA NON-PROFIT CORPORATION.

The undersigned incorporator(s), in order to form a non-profit corporation under the laws of the state of Florida, adopt the following Articles of Incorporation:

#### ARTICLE I

NAME. The name of the Corporation is: YOUNG ADULTS CONSCIOUS INDEPENDENT DEVELOPMENT, INC.

#### ARTICLE II

DURATION. The duration of the Corporation is perpetual.

#### ARTICLE III

PURPOSE. The purpose of the corporation is as follows:

A. This corporation is a nonprofit corporation organized under Chapter 617, Florida Statutes. It is not organized for the private gain of any person. The specific purposes of this corporation are: To establish a YOUNG ADULTS INSTITUTION/S organized and operated exclusively for one or more of the purposes as specified in section 501 (c) (3) of the Internal Revenue Code, including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under section 501 (c) (3) of the Internal Revenue Code, or corresponding section of any future federal tax code. Our purposes include but are not limited to the following:

To attract revenue for the improvement of social welfare, provide for those in need, and to provide multiple public services.

To provide its participants a safe comfortable atmosphere whereby education, health, maturity, and responsibility can be nurtured into Young adults.

To further foster a safe haven where young adults can seek refuge from our terroristic and hazardous streets.

To provide facilities, guidance, and opportunities; where young adults can develop their faculties, and an open mind; and

find themselves spiritually, mentally, and physically, thereby enhancing their consciousness; enabling the youth to become effective productive citizens.

To nourish assistance and compassion with each other, and to share and bear each others burden.

- B. To exercise all rights and powers conferred by the laws of the State of Florida upon nonprofit corporations.
- C. Provided, however, that the corporation shall not engage in any action which is not permitted to be carried on by nonprofit corporations under the Internal Revenue Code and no part of the net earnings of the Corporation shall inure to the berefit of or be distributable to its members, directors, or officers; but the Corporation shall be authorized and empowered to pay reasonable compensation to these people for services rendered, and to make payments and distributions in furtherance of its stated purpose.

#### ARTICLE IV

MEMBERS. The Corporation shall have Voting Members, who shall be elected (and may be removed) by the Voting Members, and who shall have all the rights and privileges of any class of members of the Corporation. The Bylaws may provide for Nonvoting Members of one or more classes, who shall be admitted in such manner and who shall have such :ights and privileges as are set forth in the Bylaws, but who shall not have the right to vote. Any person may become a member of any class as provided in the Bylaws. Any class of member may meet as provide in the Bylaws.

#### ARTICLE V

INITIAL REGISTERED AGENT AND OFFICE. The initial registered agent is "Dante Vicens" and the initial registered office is 3800 Lake Underhill Road Orlando, Fl 32803.

INITIAL BOARD OF DIRECTORS. The initial Board of Directors shall have 4 members whose names and addresses are:

The Bylaws shall provide the method of election of all Directors, and the number of Directors may be raised or lowered by amendment of the bylaws but shall in no case be less than three.

#### ARTICLE VII

OFFICERS. The officers of the Corporation shall consist of a Chairman, President, Chief Executive Officer; Vice-Chairman, Senior Executive Vice-President, Chief Operating Officer; Secretary, Chief Administrative Officer; Treasurer, Chief Financial Officer; and Executive Vice-President. Other officers may be provided for in the Bylaws. Each Officer shall be elected by the Board of Directors (and may be removed by the Board of Directors) at such time and in such manner as may be prescribed by the Bylaws.

#### ARTICLE 1X

NONSTOCK BASIS. The Corporation is organized (and shall be operated) on a nonstock basis within the meaning of the Florida Nonprofit Corporation Act, and shall not have the power to issue shares of any type or class of stock, but may issue membership certificates if so provided in the bylaws.

Upon the dissolution of this corporation, its assets remaining after payment, or provision for payment, of all debts and liabilities of this corporation shall be distributed for one or more exempt purposes within the meaning of Section 501 (c) (3) of the Internal Revenue Code or shall be distributed to the federal government, or to a state or local government, for a public purpose.

No substantial part of the activities of this corporation shall consist of carrying on propaganda, or otherwise attempting to influence legislation (except as otherwise provided by Section 501 (h) of the Internal Revenue Code), and this corporation shall not participate in, or intervene in (including the publishing or distribution of statements), any political campaign on behalf of, or in opposition to, any candidate for public office.

In any taxable year in which this corporation is a private foundation as described in section 509 (a) of the Internal Revenue Code, the corporation 1) shall distribute its income for said period at such time and manner as not to subject it to tax under Section 4942 of the Internal Revenue Code; 2) shall not engage in any act of self-dealing as defined in Section 4941 (d) of the Internal Revenue Code; 3) shall not retain any excess business holdings as defined in Section 4943 (c) of the Internal Revenue Code; 4) shall not make any investments in such manner as to subject the corporation to tax under Section 4944 of the Internal Revenue Code; and 5) shall not make any taxable expenditures as defined in Section 4945 (d) of the Internal Revenue Code.
