ARTICLES OF INCORPORATION
OF
NAVA KERALA ARTS CLUB, INC.

The undersigned subscriber to these Articles of Incorporation is a natural person competent to contract and hereby form a non profit Corporation under Chapter 617 of the Florida Statutes

ARTICLE 1 - NAME

The name of the corporation is NAVA KERALA ARTS CLUB, INC.

ARTICLE 2 - PURPOSE OF CORPORATION

The Corporation shall engage in any activity or business permitted under the laws of the United States and of the State of Florida mainly to promote cultural, educational, social activities and to encourage and revitalize the traditional arts and crafts of Kerala.

ARTICLE 3 - DIRECTORS

The Directors shall be elected by a majority vote of the Members of this Corporation.

ARTICLE 4 - TERM OF EXISTENCE

This corporation shall have perpetual existence.

ARTICLE 5 - CAPITAL STOCK

This corporation shall have no capital stock and shall be composed of members rather than shareholders.

ARTICLE 6 - QUALIFICATIONS OF MEMBERSHIP

The categories of membership, qualifications for membership and the manner of admission shall be as set forth in and regulated by the By Laws of the Corporation.

ARTICLE 7 - VOTING RIGHTS

Members of the Corporation will have such voting rights as are provided in the By Laws of the Corporation.

ARTICLE 8 - LIABILITIES FOR DEBTS

Neither the members nor the members of the Board of Directors or officers of the Corporation shall be liable for the debts of the Corporation.

ARTICLE 9 - REGISTERED OFFICE AND REGISTERED AGENT

The initial President of the corporation shall be Anandan Niravel whose address shall be the same as the principal office of the corporation.




ARTICLE 13 - EFFECTIVE DATE


