ARTICLE I

Name

Purpose(s)

The specific purpose(s) for which the corporation is organized is(are):

c) To engage in any lawful act or activity for which non-profit corporations may be organized under the general corporation law of the State of Florida.

d) To operate exclusively for such charitable and educational purposes as will qualify it as an exempt organization under Section 501 (c) (3) of the Internal Revenue Code 1954 or Corresponding provisions of any subsequent Federal Tax Laws.

e) This corporation shall not as a substantial part of its activities, carry on propaganda or otherwise attempt to influence legislation; nor shall it participate or intervene (by publication or distribution of any statement or otherwise) in any political campaign on behalf of any candidate for public office.

ARTICLE V

Limitation of corporate powers

The corporate powers of this corporation are as provided in section 617.0302, Florida Statutes, unless limited are as follows:

This corporation is to have any and all powers to do any and all things necessary or expedient to carry out the purposes and objectives of this corporation and as may be determined by the Board of Directors and subject to the By-Laws and to possess all rights, privilege and immunities and to enjoy benefits granted Non-Profit Corporation under the Laws of the State of Florida.

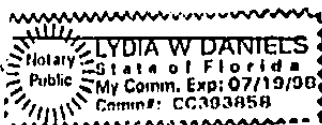
