The undersigned, acting as Incorporator(s) of a Corporation pursuant to the Statutes, adopt(s) the following Articles of Incorporation for such corporation:

Article I

The name of the corporation is: Jubilator Foundation, Inc., and the initial principal address of the corporation is: 1408 N.W. 51st Terrace, Gainesville, FL 32605

Article II

The period of the duration of this corporation is 10 (ten) years, unless dissolved according to law. Corporate existence shall commence upon filing with the Secretary of State.

Article III

The purpose or purposes for which the corporation is organized are: To conduct and promote biological research and education and to support and participate in conservation and development efforts. The corporation may hold tangible and intangible property in furtherance of these purposes.
