A NON-PROFIT CORPORATION

The undersigned subscriber to these Articles of Incorporation, a natural person competent to contract hereby forms a corporation under the laws of the State of Florida.

ARTICLE I. The name of the corporation is FAITH THEATRE, INC.

ARTICLE II. This corporation may engage or transact any and all lawful activities or business permitted under the laws of the state of Florida. The purpose of this corporation is to serve as a not-for-profit administrative parent company to smaller artistic groups which serve the community by offering instruction, career opportunities, performances of a professional quality, and scholarships to deserving underprivileged individuals, all in preservation of the arts.

ARTICLE III. The street address of the principal office of the corporation is 8061 Meridale Drive, Tallahassee, Florida.

ARTICLE IV. The street address of the initial registered office of the corporation shall be 8061 Meridale Drive, Tallahassee, Florida 32301, and the name of the initial registered agent of the corporation at that address is Cheryl Chalus.

ARTICLE V. The corporation shall have perpetual existence, unless sooner dissolved, according to law.

ARTICLE VI. Qualifications of membership are to be regulated by the bylaws of the corporation.

ARTICLE VII. The directors of the corporation shall be chosen by the process proscribed in the bylaws of the corporation, to be adopted.
