## Articles of Incorporation

of

# FLORIDA AIDS SUPPORT TEAMS, INC.

A FLORIDA NONPROFIT CORPORATION

Article 1. Name The name of the Corporation is FLORIDA AIDS SUPPORT TEAMS, INC.

Article 2. Duration The duration of the Corporation is perpetual

Article 3. Purposes. The purpose of the corporation is as follows:

- A. This corporation is a not-for-profit corporation organized under Chapter 617 of the Florida Statutes. It is not organized for the private gain of any person. The specific purposes of this corporation are to support and serve the needs of those citizens infected and/or affected by the HIV virus through means of direct and indirect service provision.
- B To exercise all rights and powers conferred by the laws of the State of Florida upon nonprofit corporations.
- C. Provided, however, that the corporation shall not engage in any action which is not permitted to be carried on by nonprofit corporations under the Internal Revenue Code and no part of the net earnings of the Corporation shall inure to the benefit of or be distributed to its members, directors, or officers; but the corporation shall be authorized and empowered to pay reasonable compensation to these people for services rendered, and to make payments and distributions in furtherance of its stated purposes.
- Article 4. Members. The Corporation Board of Directors shall be the only Voting Members, who shall be elected and may be removed by the Voting Members, and who shall have all the rights and privileges of members of the Corporation. The Bylaws may provide for Nonvoting Members of one or more classes, who shall be admitted in such manner and who shall have such rights and privileges as are set forth in the Bylaws, but who shall not have the right to vote.
- Article 5. Initial Registered Agent and Office. The initial registered agent is Wayne Stodghill and the initial registered office is 5701 N. Florida Ave, Tampa, Florida, 33604.

Article 6. Initial Board of Directors. The initial Board of Directors shall have four members whose names and addresses are:

The bylaws of the Corporation shall provide the method of election of all Directors, and the number of Directors may be raised or lowered by amendment of the bylaws but shall in no case be less than three.

Article 7. Officers. The officers of the Corporation shall consist of a President, Vice President, Secretary, and Treasurer. Other officers may be provided for in the Bylaws. Each Officer shall be elected by the Board of Directors (and may be removed by the Board of Directors) at such time and in such manner as may be prescribed by the Bylaws.
