ARTICLES OF INCORPORATION

The name of this corporation is Iskcon South Florida Inc.

II

The principal place of business and mailing address of this corporation shall be: 3220 Virginia St. Miami, FL. 33133.

III

This corporation shall exist perpetually.

IV

The purpose of the corporation is to engage in any lawful act or activity for which corporation may be organized under the Florida Corporation Not For Profit Statutes.

The corporation is organized and shall be operated exclusively for religious, charitable, literary and educational purposes, within the meaning of Section 501 (c) (3) of the Internal Revenue Code of 1954, and regulations promulgated thereunder and particularly for the following purposes:

a) Systematically propagating spiritual knowledge to society at large and educating all peoples in the techniques of spiritual life in order to check the unbalance of values in life and to achieve real unity and peace in the world; b) Propagating a consciousness of Krishna as it is reveled in the authorized Vedic literature as translated by His Divine Grace A. C. Bhaktivedanta Swami Prabhupada;

- c) Bringing the adherents of Krishna consciousness together with each other and nearer to Krishna, the prime entity and thus developing the idea, within the membership and humanity at large that each soul is part and parcel of the quality of Godhead (Krishna);
- d) Teaching and encouraging the practice of Sankirtana, congregational chanting of the holy name of God, as revealed in the teaching of Lord Sri Caitanya Mahaprabhu;
- e) With a view toward achieving the aforementioned purposes, publishing and distributing periodicals, magazines, books, and other writings;
- f) Receiving, administering and distributing funds and doing all other things necessary and proper in furtherance of the above stated purposes;
- g) Giving protection to cows and bulls, even in their old age, recognizing the cow as a mother who gives milk to the human society and the bull as a father whose labor in the fields produce the grains;
- h) Preparing and distributing prasadam, which is sanctified foodstuffs: and
- Exercising all the powers set forth under Florida Not For Profit Statutes.

The only members of this corporation shall be the Board of Directors and only members of the Board of Directors have the authority to vote on matters of this corporation. The qualifications of members and the manners of their election will be stated within the Bylaws.

- (a) No part of the net earnings of the corporation shall inure to the benefit of, or be distributed to its trustees, officers or others private persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in Article IV hereof.
- (b) No substantial part of the activities of the corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the corporation shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of any candidate for public office.
- (c) Notwithstanding any other provision of these articles, the corporation shall not carry on any other activities not permitted to be carried on (a) by a corporation exempt from federal income tax under section 501 (c) (3) of the Internal Revenue Code, or corresponding section of any future federal tax code, or (b) by a corporation, contributions to which are deductible under section 170 (c)(2) of the Internal Revenue Code, or corresponding section of any future federal tax code.
- (d) Upon the dissolution of the corporation, the Board of Directors shall, after paying or making provision for the payment of all of the liabilities of the corporation, dispose of all the assets of the corporation exclusively for the purposes of the corporation in such manner, or to such organization or

organizations organized and operated exclusively for charitable, educational, literary, scientific, or religious purposes as shall at the time qualify as an exempt organization or organizations under Section 501 (c)(3) of the Internal Revenue Code of 1954 the corresponding division of any future United States law), the Board of Directors shall determine. Any such assets not 60 disposed shall be disposed of by the Court of Common Pleas of county in which the principal office of the corporation is located, exclusively for such purposes or to such organization or organizations as said court shall determine, which are organized and operated exclusively for such purposes.
