ARTICLE I

Name

1.1. The name of the corporation is **FLORIDA ASSOCIATION OF TEMPORARY SERVICES ORGANIZATIONS, INC.**

ARTICLE II

Duration

2.1 This corporation shall have perpetual existence commencing on the date of filing of these Articles of Incorporation with the Department of State of Florida.

ARTICLE III

Purpose

3.1 To coordinate, promote, and assist in the activities, interests, and objectives of temporary service organizations, including associations, or groups of temporary services to take in as associates other organizations concerned with the temporary services industry, to negotiate and interact with other organizations on behalf of the temporary service organizations in the State of Florida.

ARTICLE IV

4.1 The qualifications for members and the manner of their admission are as provided in the Bylaws of the Corporation.

ARTICLE V

5.1 The corporation is organized under a non-stock basis.

Amendment

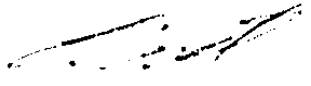
