By these articles of incorporation the incorporator form a non-profit corporation under Florida Law.

### ARTICLE I

#### NAME AND LOCATION OF PRINCIPAL OFFICE

### ARTICLE II

#### TERM

This corporation shall exist perpetually.

### ARTICLE III

#### PURPOSE

This corporation is formed for such purposes as will qualify it as an exempt organization under Section 501 (c) (3) of the Internal Revenue Code of 1986, as amended ( the "Code") including for such purposes, the making of distributions for organizations which qualify as tax-exempt organizations.

Within the scope of the forgoing, the object of this corporation and its purposes are solely benevolent. Its purpose is exclusively, literary, charitable, scientific and educational within the meaning of section 501 (c) (3) of the Internal Revenue Code of 1986 of the corresponding provisions of any future United States Internal Revenue law. No part of the net earnings of the corporation shall inure to the benefit of any member, director or officer of the corporation or any private individual ( except that reasonable compensation may be paid for services rendered to or for the corporation affecting one or more of its purposes ) and no Member, Director

Upon the dissolution of the corporation, assets shall be distributed for one or more exempt purposes within the meaning of section 501 (c) (3) of the Internal Revenue Code, or corresponding section of any future federal tax code, or shall be distributed to the Federal, state, or local government for a public purpose.

Any such assets not so disposed of shall be disposed of by a court of competent jurisdiction of the county in which the principal office of the organization is then located, exclusively for such purposes.

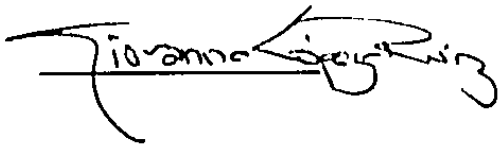
