ARTICLES OF INCORPORATION OF NEW TESTAMENT CHURCH - GUYANA, SOUTH AMERICA, INC. (A Florida Nonprofit Corporation)

We, the undersigned, desiring to associate for the purpose of forming a corporation not for profit under the provisions of Chapter 617, Florida Statutes, do hereby agree to the following:

ARTICLE I - NAME AND LOCATION

The name of this corporation of NEW TESTAMENT CHURCH - GUYANA, SOUTH AMERICA, INC., of 2478 Palmetto Avenue, Sanford, Florida, 32771.

ARTICLE II - PURPOSES

This is a nonprofit corporation organized for the purpose of advancing the Christian faith and the gospel of Jesus Christ and to conduct all lawful business not for pecuniary profit and not specifically prohibited to corporations under the laws of Florida.

ARTICLE III - DURATION

This corporation shall have perpetual existence.

ARTICLE IV - NONSTOCK CORPORATION

This corporation shall be nonstock, and no dividends or pecuniary profits shall be declared or paid to the members thereof.

ARTICLE V - INITIAL REGISTERED OFFICE AND AGENT
