**ARTICLES OF INCORPORATION  
OF  
NEW TESTAMENT CHURCH - GUYANA, SOUTH AMERICA, INC.  
(A Florida Nonprofit Corporation)**

We, the undersigned, desiring to associate for the purpose of forming a corporation not for profit under the provisions of Chapter 617, Florida Statutes, do hereby agree to the following:

**ARTICLE I - NAME AND LOCATION**

The name of this corporation of **NEW TESTAMENT CHURCH - GUYANA, SOUTH AMERICA, INC.**, of 2478 Palmetto Avenue, Sanford, Florida, 32771.

**ARTICLE II - PURPOSES**

This is a nonprofit corporation organized for the purpose of advancing the Christian faith and the gospel of Jesus Christ and to conduct all lawful business not for pecuniary profit and not specifically prohibited to corporations under the laws of Florida.

**ARTICLE III - DURATION**

This corporation shall have perpetual existence.

**ARTICLE IV - NONSTOCK CORPORATION**

This corporation shall be nonstock, and no dividends or pecuniary profits shall be declared or paid to the members thereof.

#### ARTICLE V - INITIAL REGISTERED OFFICE AND AGENT

The street address of the initial registered office of this corporation is 2478 Palmetto Avenue, Sanford, Florida, 32771, and the name of the initial registered agent of this corporation is **VIRGINIA W. POWELL**.

#### ARTICLE VI - INITIAL BOARD OF DIRECTORS

This corporation shall have three (3) directors initially. The number of directors may be increased from time to time, but shall never be less than three (3). determined by the Bylaws of this corporation, but notwithstanding any provisions in the Bylaws, all persons to be qualified as members hereof shall have professed Christ and have been baptized according to the teachings of the Word of God, the Bible, and shall be admitted only upon the profession of faith in Christ, the baptism as aforesaid, and on a majority vote of those members present and voting at any regular church meeting.



#### **ARTICLE IX - AMENDMENT**






