ARTICLE I - NAME

This name of the Corporation is CVW BOCA RATON AUXILIARY OF THE HABILITATION CENTER FOR THE HANDICAPPED, INC., a Non-Profit Corporation.

ARTICLE II - DURATION

This Corporation shall exist perpetually commencing on the date these Articles are filed.

ARTICLE III - PURPOSE

This Corporation is organized for the purpose of conducting any lawful business permitted in the State of Florida under the Non-Profit Corporation Statutes.

ARTICLE IV - QUALIFICATION OF MEMBERS AND MANNER OF ADMISSION

ARTICLES OF AMENDMENT

ARTICLES OF INCORPORATION

OF.

CVW BOCA AUXILIARY OF THE CENTER FOR

THE HANDICAPPED, INC.

FIRST: Pursuant to Article XI - Amendment of the Articles of Incorporation of the CVW BOCA AUXILIARY OF THE HABILITATION CENTER FOR THE HANDICAPPED, INC., Article III is amended by adding the following at the end thereof.

a. Said corporation is organized exclusively for charitable, religious, educational, and scientific purposes, including for such purposes, the making of distributions to organizations that qualify as exempt organizations under section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code.

b. No part of the net earnings of the corporation shall inure to the benefit of, or be distributable to its members, trustees, officers, or other private persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in the purpose clause hereof. No substantial part of the activities of the corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the corporation shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign behalf of or in opposition to any candidate for public office. Notwithstanding any other provision of these articles, the corporation shall not carry on any other activities not permitted to be carried on (1) by an organization exempt form federal income tax under section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code.

c. Upon the dissolution of the corporation, assets shall be distributed for one or more exempt purposes within the meaning of section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government, for a public purpose. Any such assets not so disposed of shall be disposed of by a Court of Competent Jurisdiction of the county in which the principal office of the corporation is then located, exclusively for such purposes or to such organization or organizations, as said Court shall determine, which are organized and operated exclusively for such purposes.

- **SECOND:** The date of adoption of the amendment was August $\frac{4}{1}$, 1997.
- **THIRD:** There are no members entitled to vote on the amendment. The amendment was adopted by the board of directors.
