The undersigned, as the directors of the PALM BEACH COUNTY ALZHEIMER'S CARE ASSOCIATION, INC. (hereinafter "the Corporation") hereby adopt this resolution recommending a plan of distribution and directing its submission to a vote of the members as provided in Florida Statute 617.1406 and state:

Whereas, each of the directors hereby waives notice of this proceeding;

Whereas, the Corporation was administratively dissolved on September 26, 1997 for failure to file its annual report. As provided by Florida Statute 617.1421(3) the Corporation continues its corporate existence but may not conduct any affairs expect that necessary to wind up and liquidate its affairs under Florida Statue 617.1405 and adopt a plan of distribution of assets pursuant to Florida Statue 617.1406;

Whereas, Article XV of the Articles of Incorporation of Palm Beach County Alzheimer's Care Association, Inc. provides as follows:

Upon the dissolution of the Corporation, the Members shall, after paying or making provision for the payment of all other liabilities of the Corporation, dispose of all of its assets exclusively for the purposes of the Corporation in such manner, or to such organizations organized and operated exclusively for charitable, educational, religious or scientific purpose as shall at the time qualify as an exempt organization or organizations under section 501 (c)(3) of the Internal Revenue Code (or the corresponding provision of any future United States Internal Revenue Laws) as the Members shall determine. Any such assets not disposed of shall be disposed of by the Circuit Court of the county in which the principal office of the Corporation is then located, exclusively for such purpose or to such organization or organizations, as the said court shall determine, which are organized and operated exclusively for such purpose.

Whereas, Florida Statue 617.1406 states that a plan of distribution of assets must provide that:

- a. All liabilities and obligations of the corporation be paid in discharged, or adequate provisions be made therefor;
- Assets held by the corporation upon condition requiring return, transfer, or conveyance, which condition occurs by reason of the dissolution, he returned, transferred, or conveyed in accordance with such requirements;
- c. Assets received and held by the corporation subject to limitations permitting their use only for charitable, religious, eleemosynary, benevolent, educational, or similar purposes, but not held upon a condition requiring return, transfer, or conveyance by reason of the dissolution, to be transferred or conveyed to one or more domestic or foreign corporations, trust, societies, organizations engaged in activity substantially

- similar to those of the dissolving corporation, as provided in the plan of distribution of assets;
- d. Other assets, if any, be distributed in accordance with the provisions of the articles of incorporation or the bylaws to the extent of the articles of incorporation or the bylaws determine the distributive rights of members, or any class or classes and members, or provide for distribution to others; and
- e. Any remaining assets be distributed to such persons, trust, societies, organizations, or domestic or foreign corporations, whether perfect for profit or not-for-profit, as specified in the plan of distribution of assets.

Whereas, the current assets of the Corporation consist solely of the funds held in the corporate account(s) located at the US Trust Company of Florida in the approximate total amount of Twenty-five Thousand Dollars (balance(s) as of June 1, 2001.
