The undersigned incorporator, for the purpose of forming a not for profit corporation under the Florida Not for Profit Corporation Act, hereby adopts the following Articles of Incorporation.

ARTICLE I. NAME

The name of the corporation shall be:

ARTICLE II. NATURE OF BUSINESS

ARTICLE V. TERM OF EXISTENCE


