The undersigned incorporators to these Articles of Incorporation, by these articles form a corporation not for profit, pursuant to Chapter 617 of Florida Statutes and other laws of the State of Florida.

FIRST: The name of the corporation is ADAC INTERNACIONAL, INC.

SECOND: The period of duration of the corporation is perpetual.

THIRD: The purpose is to engage in a NOT FOR PROFIT business to religious evangelistic events from the Catholic Church.

FOURTH: This corporation is not authorized to issue any shares of stock.

FIFTH: The address of its initial registered office is 1457 N.W. 124 Avenue, Pembroke Pines, FL 33026, and the name of the initial registered agent at such address is Pedro Hernandez.

SIXTH: The initial board of directors will consist of three directors: Pedro Hernandez 1457 N.W. 124 Ave., Pembroke Pines, FL 33026 and Maria Hernandez, 1457 N.W. 124 Ave., Pembroke Pines, FL 33026 and Aminta Valls, 833 Coral Way, Miami, Florida.

The qualifications of the above directors and the manner of their admissions are regulated by the bylaws of this not-for-profit corporation.

SEVENTH: The names and addresses of the incorporators are Pedro Hernandez and Maria Hernandez, 1457 N.W. 124 Avenue, Pembroke Pines, FL 33026.

EIGHTH: The initial members of this corporation are: Pedro Hernandez and Maria Hernandez, 1457 N.W. 124 Ave., Pembroke Pines, FL 33026 and Aminta Valls, 833 Coral Way, Miami, FL

NINTH: VOTING RIGHTS. All members of this Corporation will share equal voting rights.

TENTH: The street address of the principle office of the Corporation in the State of Florida is, 1457 N.W. 124 Avenue, Pembroke Pines, FL 33026.

ELEVENTH: The Corporation shall indemnify Incorporators, Officers and Directors to the full extent permitted by law.

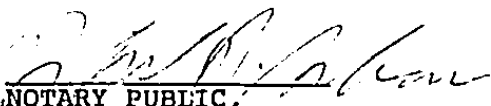

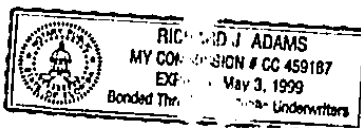
