ARTICLES OF INCORPORATION
OF

ALLAPATTAH CHAMBER OF COMMERCE COMMUNITY SERVICES, INC.

The undersigned incorporator, for the purpose of forming a non-profit corporation under the laws of the State of Florida, hereby adopts the following Articles of Incorporation.

ARTICLE I
NAME

The name of this corporation shall be:
ALLAPATTAH CHAMBER OF COMMERCE COMMUNITY SERVICES, INC.

ARTICLE II
NONPROFIT CORPORATION

The corporation is a nonprofit corporation.

ARTICLE III
DURATION

This corporation shall have perpetual existence, commencing upon the filing of these Articles of Incorporation with the Department of State, State of Florida.

ARTICLE IV
PURPOSES AND POWERS

4.01 This corporation is organized exclusively for charitable, and educational purposes as defined in Section 501(c)(3) of the Internal Revenue Code. Furthermore, this corporation is not authorized to have any powers that a Section 501 (c) (3) organization is not authorized to have.

4.02 No part of the net earnings of the Corporation shall inure to the benefit of any director of the Corporation, officer of the Corporation, or any private individual (except that reasonable compensation may be paid for services rendered to or for the corporation affecting one or more of its purposes); and no director, officer or any private individual shall be entitled to share in the distribution of any of the corporate assets on dissolution of the Corporation. No substantial part of the activities of the Corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the Corporation shall; not participate in, or intervene in (including the publication or distribution of statements) any political campaign on behalf of any candidate for public office.

4.03 The corporation shall not conduct or carry on any activities not permitted to be conducted or carried on by an organization exempt from taxation under Section 501(c)(3) of the Internal Revenue Code and its Regulations as they now exist or as they may hereafter be amended, or by an organization, contributions to which are deductible under 170 (c) (2) of the Internal Revenue Code and Regulations as they now exist or as they may hereafter be amended.

4.04 Upon dissolution of the Corporation or the winding up of its affairs, the assets of the Corporation shall be distributed exclusively to charitable organizations which would then qualify under the provisions of Section 501 (c) (3) of the Internal Revenue Code and its Regulations as they now exist or as they may hereafter be amended.

d. The corporation is organized pursuant to the Florida General Corporation Law and does not contemplate pecuniary gain or profit and is organized for nonprofit purposes.

ARTICLE V MEMBERSHIP

The corporation shall have no voting members.

ARTICLE VI INITIAL CORPORATE OFFICE AND REGISTERED OFFICE AND AGENT



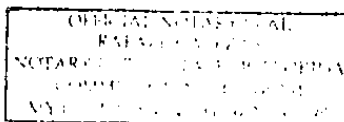
