ARTICLES OF INCORPORATION

OF

GENERATION JESUS CHILD HOUSE MINISTRIES, INC.

ARTICLE I - NON-PROFIT CORPORATE NAME

The name of this Non-profit Corporation is Generation Jesus Child House Ministries, Inc., whose principal office and mailing address is 12000 Highway 90, Melbourne, Florida 32935.

ARTICLE II - NATURE OF BUSINESS AND POWERS

This Corporation is a NOT FOR PROFIT Corporation organized under the laws of the State of Florida. It is not organized for the private inurement of any person. The specific purpose of this corporation are as follows:

TO PROVIDE TRAINING TO THE TEACHINGS OF JESUS CHRIST TO CHILDREN, AND TO PROVIDE TRAINING TO THEIR DAILY LIVES.

TO PROVIDE A WELL-STRUCTURED SHELTER, REFUSE AND SUPPORT CENTER TO AT-RISK AND IN-CRISIS CHILDREN. (For the purpose of

this Corporation AT-RISK CHILDREN are those children who are not properly exposed to drugs, alcohol, neglect, mental and physical abuse and early exposure to sexual activity, incest and molestation. Children in crisis are those children who have run

from home, been removed from the home by a State or County

authorities, and are in need of a safe and secure environment.

54. TO MAKE REFERRALS AND TRANSPORT CHILDREN TO NEEDED MEDICAL, DENTAL, COUNSELLING AND OTHER SERVICES.

55. TO TAKE AN ACTIVE ROLE IN THE EDUCATION AND TRAINING OF CHILDREN, BE ORDERED TO GO OUT AND ENCOURAGE THESE CHILDREN TO ABSTAIN FROM VIOLENCE AND STRIVE FOR SUCCESS THROUGH EDUCATION, MORAL CONDUCT, ACCEPTABLE SOCIAL SKILLS, AIDS/HIV AWARENESS (INCLUDING ALL SEXUALLY TRANSMITTED DISEASES), CHRISTIAN CONFLICT MANAGEMENT AND PEACE-KEEPING SKILLS.

56. TO WORK WITH CHILDREN TO UNDERSTAND THEIR CONSCIOUSNESS AND SELF-WORTH. WE WILL EXPLORE RELATIONSHIPS, (male-female, parent-child, boss-employee, race, religious, etc...).

57. TO ADVISE COURTS HEARINGS IN REFERENCE TO THE SAFETY AND WELL-BEING OF CHILDREN, ACTING SOLELY ON BEHALF OF THE CHILD/CHILDREN. WHERE CUSTODY REUNIFICATION IS NOT POSSIBLE, WE WILL FIND OR DECIDE THE PERMANENT/LEGAL GUARDIAN OR ADOPTIVE CHRISTIAN FAMILY AND HOME FOR THE CHILD/CHILDREN.

58. WE STRIVE ALLOWING SIBLINGS TO REMAIN TOGETHER AS A FAMILY UNIT WHERE IT IS POSSIBLE.

59. TO ASSIST IN LOCATING EMPLOYMENT FOR CHILDREN OF AGE.

60. TO EXERCISE ALL RIGHTS AND POWERS CONFERRED BY THE LAWS OF THE

REPUBLIC OF UGANDA AND THE CHURCH OF UGANDA

It is hereby declared, however, that the Corporation shall not engage in any activity which is prohibited to be carried on by a non-profit corporation under the Internal Revenue Code and no part of the net income of the Corporation shall inure to the benefit of or for the private inurement to its members, directors, or officers; but the Corporation shall be authorized and empowered to pay reasonable compensation to these people for services rendered, and to make payments and distributions in furtherance of its stated purposes.

ARTICLE III - NONSTOCK BASIS

Corporation is organized (and shall be operated) on a nonstock basis within the meaning of the Florida Not For Profit Corporation Act, and shall not have the power to issue shares of any type or amount of stock, but may issue membership certificates if so provided in the bylaws.

ARTICLE IV - TERM OF EXISTENCE

Notwithstanding Corporation shall have perpetual existence, commencing upon filing of these articles.

ARTICLE V - REGISTERED AGENT AND INITIAL REGISTERED OFFICE

ARTICLE VI - BOARD OF DIRECTORS

This Non Profit Corporation shall have three directors initially. The number of directors may be increased or diminished from time to time by the Board of Directors, but shall never be less than three (3).

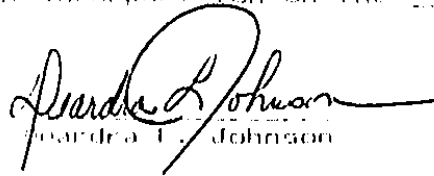

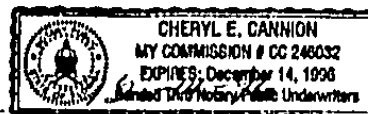

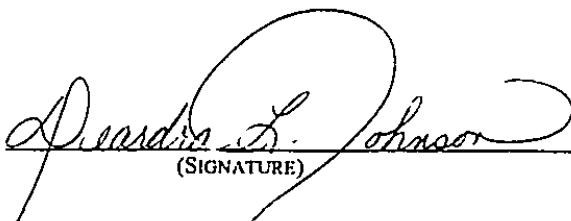
