ARTICLES OF INCORPORATION

ALMSWAY MINISTRIES, INC

(A Florida Non-Profit Corporation)

The Understaned, acting as incorporator of a corporation/ ORIDA pursuant to Chapter 617, Florida Statutes, adopt the following Articles of Incorporation for such corporation:

ARTICLE I

The Name of the corporation is ALMSWAY MINISTRIES INC.,

ARTICLE 11

The principal place of business and mailing address of this corporation shall be: 680 Brookfield Loop, Lake Mary, Florida 32746.

ARTICLE III

The specific purpose for which the corporation is organized is exclusively religious and charitable within the meaning of section 501(c)(3) of the Internal Revenue Code cr 1986 or the corresponding provision of any future United States Interal Revenue Law. This society shall be to provide food, clothing; household supplies and furnishings for disadvantaged, needy individuals and families of any race, creed, color, sex or age.

ARTICLE IV

The manner in which the directors are elected or appointed is as follows:

All Directors, Officers and Board Members shall be elected by a minimum of four (4) Board Members for a term of one year, and serve until their successors are elected and installed. The Officers of the Board of Directors are Prosident, Vice President, Secretary, and Treasurer. This is so stated in the By-Laws.

Any active member of the Board of Directors in good standing is eligible to any office provided he or she meets the provisions set forth in the BY-Laws.

In the case of death, disability or resignation of any elected officer, the President shall appoint a successor for the balance of the term.

ARTICLE V

The Corporate powers of this Corporation are as provided in section 617.0302, Florida Statutes.

ARTICLE VI

ARTICLE VIII

This corporation is organized under a non-stock basis.

Notwithstanding any other provision of these articles, this organization shall not carry on any activities not permitted to be carried on by an organization exempt from federal income tax under section 501(c)(3) of the Internal Revenue Code of 1986 or the corresponding provisions of any future United States Internal Revenue Law.

ARTICLE IX

Upon dissolution of the organization, assets shall be distributed for one or more exempt purposes within the meaning of section 501(c)(3) of the Internal Revenue Code of 1986 or corresponding section of any future federal tax code, or shall be distributed to the Federal, State or Local Government for a public purpose. Any such assets not so disposed of shall be disposed of by the Court of Common Pleas, of the County in which the principal office of the organization is then located, exclusively for such purposes.

ARTICLE X

The corporation may amend or repeal any article of those Articles of Incorporation, or revise the same in toto, by two thirds vote of its active members present at any regular, annual

or special mosting calls for that purpose.

ARTICLE XI

No person, firm or corporation shall over receive any dividends or profits from the undertakings of this corporation, and upon dissolution of this corporation, all of its assets remaining after payment of all costs and expenses of such dissolution shall be distributed to organizations which have qualified under Section 501(c)(3) of the Internal Revenue Code, or to the Federal Government, or to a State or Local Government, for a public purpose, and none of the assets will be distributed to any member, officer, or trustee of this corporation.

ARTICLE II
