# Articles of Incorporation for SET FREE IF YOU WANT TO BE, INC.

The undersigned, being of legal age and competent to contract, acting as incorporator of a corporation not for profit pursuant to Chapter 617, Florida Statutes, adopts the following Articles of Incorporation:

# Article I

#### NAME

The name of the corporation shall be: Set Free If You Want To Be, Inc.

# Article II

#### PRINCIPAL PLACE OF BUSINESS AND MAILING ADDRESS

# Article III

#### **PURPOSES**

The specific purposes for which the corporation is organized is as a ministry exclusively for religious, educational, charitable and benevolent purposes within the meaning of Section 501(c)(3) of the Internal Revenue Code of 1986 (or the corresponding provision of any future United States Revenue Law), including, but not limited to, for such purposes as training to teach people how to minister to the sexually wounded; the writing, editing and publishing of materials relating to the ministry; the proclaiming of the Gospel of the Lord Jesus Christ and the education of believers in a manner consistent with the requirements of Holy Scripture, both in Sunday and weekday schools of Christian education; the maintaining of missionary activities in the United States and any foreign country; the building, maintaining and operating of churches, parsonages, schools (including all

secondary academic levels and preschools), chapels, radio stations, television stations, rescue missions, print shops, daycare centers, camps, nursing homes, hospitals, and cemeteries and the engaging in any other ministry that the corporation may decide, from time to time, to pursue in obedience to the will of God.

# **Article IV**

#### MANNER OF ELECTION OF DIRECTORS

The manner in which the directors are elected or appointed shall be as stated in the bylaws.

# Article V

#### INITIAL BOARD OF DIRECTORS

The number of directors constituting the initial board of directors is four. The number of directors may be increased or decreased from time to time in accordance with the bylaws, without amendment of these articles of incorporation, but shall never be less than three. # **Article VI**

#### LIMITATION OF CORPORATE POWERS

The corporate powers of this corporation are as provided in Section 617.0302, Florida Statutes, unless limited as follows:

This corporation is formed exclusively for religious, charitable, scientific, educational, literary, civic and social welfare purposes. Notwithstanding any other provision of these Articles of Incorporation, this corporation shall not carry on any other activities not permitted to be carried on by an organization exempt from Federal Income Tax under Section 501(c)(3) of the Internal Revenue Code of 1986 (or the corresponding provision of any future United States Revenue Law) or by an organization, contributions to which are deductible under Section 170(c)(2) of the Internal Revenue Code of 1986 (or the corresponding provision of any future United States Revenue Law).

No part of the net earnings of the corporation shall inure to the benefit of, or be distributable to its directors, officers, members or other private persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for

services rendered and to make payments and distributions in furtherance of the purposes set forth in these Articles of Incorporation. No substantial part of the activities of the corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the corporation shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of or in opposition to any candidate for public office.

The corporation shall have a racially nondiscriminatory policy.
