The undersigned, acting as Incorporator(s) of a corporation pursuant to Chapter 617, Florida Statutes, adopt(s) the following Articles of Incorporation:

ARTICLE I

Name

ARTICLE IV

Manner of election of directors

An affirmative vote of three fourths of those members present will validate the choice. The Directors shall be replaced or elected for a new term at the annual election of officers of the corporation.

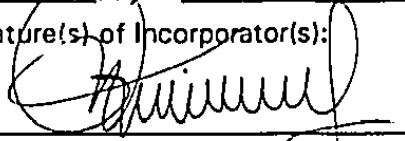

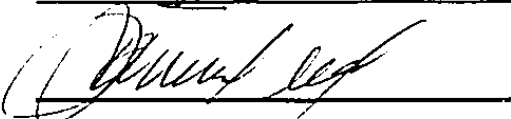

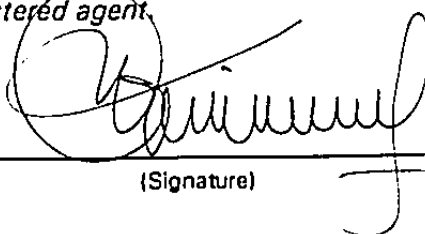
