The undersigned subscribers to these Articles of Incorporation, each a natural person competent to contract, hereby associate themselves together to form a non-profit corporation under the laws of the State of Florida.

ARTICLE I

The name of the proposed corporation is **SAFE DRIVER EXPRESS, INC.**

ARTICLE II

The general nature of the business to be transacted by this corporation shall be to engage in any activity or business entailing the driving of persons to and from restaurants and other establishments after consuming alcoholic beverages as permitted under the laws of the United States and the State of Florida and to have and exercise any and all other powers conferred by the Laws of Florida upon corporations formed in the State of Florida.

ARTICLE III

The maximum number of memberships that this corporation is authorized to issue and have outstanding at any one time is 1,000.00 memberships.

The address of the initial office of this corporation is 512 Clomatis Street, West Palm Beach, Florida. The name of the initial registered agent at that address is T.G. BROWN, ESQUIRE.

#### ARTICLE IV

The amount of capital with which this corporation shall begin business is not less than Five Hundred Dollars (\$500.00).

This corporation shall exist perpetually unless dissolved according to law.



The undersigned, being all of the directors of the corporation, hereby amend the previous Articles of Incorporation pursuant to Florida Statutes §617.017 and §617.0201 regarding a corporation not for profit under Florida Statutes §617.01 et seq. and hereby adopt the following Articles of Incorporation:

ARTICLE ONE

The name of the corporation is SAFE DRIVER EXPRESS, INC. The address of the corporation's principal office and mailing address is 1409 10<sup>th</sup> Street, Lake Park, Florida 33403.

ARTICLE TWO

The purposes for which the corporation is formed are:

- (1) To drive persons to and from restaurants and other establishments at which such persons consume alcoholic beverages;
- (2) To prevent drunk driving;
- (3) To collect and otherwise raise money for the purposes stated herein;
- (4) To cooperate with federal, state, and local government agencies to achieve the purposes stated herein; and
- (5) To do everything lawful, necessary, suitable, and proper to attain the charitable purposes set forth herein.

ARTICLE THREE

The conditions and regulations of membership and the rights and privileges of the classes of membership shall be determined and fixed by the bylaws.

ARTICLE FOUR

The term of existence of this corporation is perpetual.

ARTICLE FIVE

#### ARTICLE TEN

#### ARTICLE ELEVEN

The private property of members of the corporation shall not be liable for corporate debts.

#### ARTICLE TWELVE

(1) No part of the net earnings of the corporation shall inure to the benefit of, or be distributable to, any director or officer of the corporation or any member of the corporation or any other private individual (except that reasonable compensation may be paid for services rendered to or for the corporation affecting one or more of its purposes), and no director or officer of the corporation or any private individual shall be entitled to share in the distribution of any of the corporate assets on dissolution of the corporation. Upon dissolution of the corporation, any remaining assets after payment of outstanding liabilities shall be contributed to any one or more 501(c)(3) qualifying tax exempt organizations.


