

ARTICLE I

The name of the corporation shall be PULPITEER.ORG., INCORPORATED (the "Corporation").

ARTICLE II

The street address of the initial principal office and mailing address of the Corporation shall be 4852 34th Avenue North, St. Petersburg, Florida 33713.

ARTICLE III

The purpose for which the Corporation is organized is to conduct worship services, conversations, rituals, and message exchange between persons of all world religions by means of the communications network called the internet; to establish a Web Center for the Social Gospel in a site connected to the World Wide Web, to publish tracts, magazines, and literature on subjects of religion and spiritualities, including recovery from addiction and substance abuse, in electronic form as well as in other media forms.

The corporation shall also be authorized to engage in and transact any and all lawful business within and without the State of Florida or United States for which corporations not for profit may be incorporated under Chapter 617, Florida Statutes, as amended and supplemented.


