The undersigned, acting as incorporators of a Corporation pursuant to Chapter 617, Florida Statutes, adopt the following Articles of Incorporation for such corporation:

ARTICLE I

The name of the corporation shall be: SALVATION, POWER, PRAISE & DELIVERANCE-HOLINESS CHURCH, INCORPORATED.

The period of the duration of this corporation is perpetual unless dissolved according to law.






