ARTICLES OF INCORPORATION

PINE TRACE PROPERTY OWNERS ASSOCIATION, INC.

The undersigned subscribers to these Articles of Incorporation, each a natural person competent to contract, hardby associate themselves together to form a corporation not for profit under Chapter 617 of the laws of the State of Florida.

ARTICLE I.

NAME

The name of this corporation is PINE TRACE PROPERTY OWNERS ASSOCIATION, INC.

ARTICLE II

PURPOSES

The corporation is organized as a non-profit corporation under Chapter 617, Florida Statutes, for the following purposes:

- a. To obtain, receive, hold title to, convay, assign, manage, maintain, operate and care for real and personal property, including but without limitation, all easements, roads, parks, lakes, ditches, canals, retention or detention areas, drainage and other surface water management works, preservation or conservation areas, wetlands and wetland mitigation areas, and other common areas, which are owned by this Corporation, or the owners in common.
- b. To facilitate transactions and communications among persons owning property in the development known as Pine Trace Subdivision.
- c. To fix and make assessments against persons and entities owning property in Pine Trace Subdivision, and collect these assessments, together with necessary court costs and reasonable attorney fees, by any lawful means.
- d. To maintain, repair, replace, operate, and care for real and personal property, including but without limitation, all lakes, ditches, canals, retention or detention areas, drainage, other surfacewater management works, and preservation or conservation areas, wetlands, and wetland mitigation areas which are owned by this association or corporation or the owners in common in a manner consistent with the permit issued by the Suwannee River Water Management District and the operation and maintenance plan attached thereto.

- e. To do and perform anything required by these articles, the bylaws, or the declaration of covenants and restrictions to be done by the owner, but if not done by the owner in a timely manner, at the expense of Owner.
- f. To do and perform any obligations imposed upon the association by the declaration of covenants and restrictions or by any permit or authorization from any unit of local, regional, state, or the federal government and to enforce by any lugal means the provisions of these articles, the bylaws and the declaration.
- g. To exercise all of the powers enumerated in Chapter 617, Florida Statutes, as it now exists or is subsequently amended or superseded, and to do and perform such acts and to have such powers as shall be desirable and necessary in furtherance of any of the powers hereinabove enumerated which are not in derogation of the laws of the State of Florida.
- h. This Corporation is organized exclusively for public purposes as a not-for-profit corporation within the meaning of Section 501 (c) (3) of the Internal Revenue Code, and its activities shall be conducted for such purposes in such a manner that no part of its net earnings shall inure to the benefit of any member, director, officer or individual. In addition, the Corporation shall be authorized to exercise the powers permitted non-profit corporation in exercising any one or which it has been organized as described in Section 501 (c) (3) or any amendments or additions thereto.

ARTICLE III.

MEMBERSHIP

Every person or entity who is, from time to time, the record owner of property within Pine Trace Subdivision shall be a member of this Corporation. Membership will be appurtenant to, and may not be separated from the ownership. The initial members of this Corporation shall consist of the incorporators identified in Article V hereof.

ARTICLE IV.

TERM

The term of this corporation shall be perpetual.

ARTICLE VI.

DIRECTORS AND OFFICERS

SECTION ONE: The property, affairs, business and operation of the Corporation shall be managed in accordance with the provisions of the By-laws by the Board of Directors, which shall be elected annually by the members as provided in the By-Laws of the Corporation. The Board shall carry out the purposes of the Corporation in compliance with the Articles of Incorporation and By-Laws of the Corporation.

SECTION TWO: The officers of the Corporation shall consist of a President, Secretary and Treasurer, who shall be members of the Board of Directors. The officers shall be appointed yearly in the manner provided by the By-laws.

ARTICLE VII

ARTICLE VIII

REGISTERED OFFICE AND AGENT

The initial registered office of the corporation shall be at 600 West Base Street, Madison, Florida 32340. The initial registered agent of the corporation shall be W. C. Copeland, III, whose mailing and physical address is 600 West Base Street, Madison, Florida 32340.

ARTICLE IX

INITIAL CONTROL BE DEVELOPER

Notwithstanding the other provisions contained in these Articles to the contrary, Eloise Stewart, or her successor in interest ("Developer") shall have exclusive control over this Corporation until the Developer relinquishes that right or ceases to be the owner of any land in Pine Trace Subdivision, whichever occurs first. The Developer, prior to relinquishing control of this Corporation or otherwise allowing control to transfer to the Directors of the Corporation, shall provide at least thirty (30) days written notice to the Suwannee River Water Management District that all terms and conditions placed upon the Developer by permits or authorization from the Suwannee River Water Management District have been satisfied in full and that transfer is proposed to occur on a specific date.

ARTICLE X

BY-LAWS

The Board of Directors shall adopt By-laws for this Corporation and may from time to time modify, alter, amend or rescind the same by a majority vote of the members of the Board of Directors present at any regular or special meeting.

ARTICLE XI

AMENDMENTS

These Articles of Incorporation may be amended at any time. Such amendment may be proposed by any member and any such proposal shall be adopted by the approval of a majority of the Board of Directors. Amendments to these Articles of Incorporation

or Bylaws which directly or indirectly impact operation and maintenance of the surfacewater management system, including but without limitation, all lakes, ditches, canals, retention or detention areas, drainage, other surfacewater management works, and preservation or conservation areas, watlands and watland mitigation areas which are owned by this Corporation or the owners in common, may be made after approval by the Suwannee River Water Management District. Such approval shall be in the form of a modification to any and all permits issued by the Suwannee River Water Management District under the lawfully adopted rules of the Suwannee River Water Hanagement District in effect at the time of application for such modification. Amendments to the Articles of Incorporation or the Bylaws which do not impact operation or maintenance of the system may be made without authorization of the Suwannee River Water Management District; however, copies of any such amendments shall be forwarded to the District within thirty (30) days of approval.

ARTICLE XI

DISSOLUTION

Upon dissolution of this Corporation, all of its assets remaining after the payment of all costs and expenses of such dissolution shall be distributed to a corporation or entity qualified under Sec 501 (c) (3) of the Internal Revenue Code. Prior to dissolution of this Corporation, all property, interest in property, whether real, personal, or mixed, which is directly or indirectly related to the surfacewater management system, including but without limitation, all lakes, ditches, canals, retention or detention areas, drainage, other surfacewater management works, and preservation or conservation areas, wetlands, and wetland mitigation areas which are owned by this Corporation or the owners in common, will be dedicated to and accepted for maintenance by the appropriate unit of government or otherwise transferred to and accepted for maintenance by an approved entity. Dedication or approval must be authorized by the Suwannee River Water Management District through modification of any and all permits or authorizations issued by the Suwannee River Water Management District. Such modification shall be made under the lawful adopted rules of the Suwannee River Water Management District in effect at the time of application for such modification.
