**ARTICLES OF INCORPORATION**

The undersigned, acting as incorporators of a corporation pursuant to chapter 617, Florida Statutes, adopt(s) the following Articles of Incorporation.

**ARTICLE I - NAME**

**ARTICLE II - PRINCIPAL OFFICE**

The board of Directors may from time to time move the principal office to any other address in Florida.

**ARTICLE III - PURPOSE(S)**

The purposes for which the Corporation is organized are:

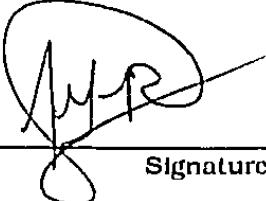
